- 1. I take full responsibility of my child school fees on time.

- 3. In the event of breach of contract Imbali Combined School could at its own discretion:
  - Withhold results and /or
  - Confiscate learning material
  - Hand over account to attornyeys for collection of all outstatinding fees after 21 days notification to parents and/or (referred to as de-registration)
